2023 HALF-YEAR ACTIVITY REPORT

The half-year activity report consists of two parts:

- an excerpt from the press release issued by the Company commenting on the activity and figures for the half-year as well as the outlook;
- financial information relating to the first half of 2022 for comparability purposes with the first half of 2023. This comparative information is made necessary by the acquisition of the IXBLUE group completed in September 2022, the target acquired therefore contributing to the 2023 half-year financial statements but not to those of 2022.

Excerpt from the press release issued on 27 September 2023

First half of 2023 results: €154 million in revenue and 21% current EBITDA margin

Good financial results

- Revenue: +14% in the first half, with an acceleration in the second quarter (+19%)

The last sale of the activities of the former Engineering & Protection Systems division was completed at the end of the first quarter of 2023, in accordance with the announced schedule. This transaction generated €30 million in cash inflows for EXAIL TECHNOLOGIES in 2023, the capital gain being fully recognized in the financial statements for the first half of the year. The ISP division only contributed to the income statement for 2022 on the income statement from discontinued activities (application of IFRS 5).

€154 million in revenue in the first half of 2023

EXAIL TECHNOLOGIES achieved revenue growth of 14% in the first half of 2023, with an acceleration in the second quarter (+19%).

Navigation & Maritime Robotics segment: advances in both civil and defense applications

The revenue of the Navigation & Maritime Robotics segment increased by 11% in the first half of 2023, reaching 20% in the second quarter of 2023. This segment includes the Group's two main activities, which are vertically integrated: the sale of navigation and positioning systems and the marketing of drones and autonomous drone systems for maritime applications. The growth in revenue was driven by three major growth vectors:

- the progress of major ongoing defense programs, in particular underwater mine counter measures programs;
- the growth of existing applications in the maritime field, for various sectors (renewable marine energies, offshore construction, etc.);
- breakthrough in fast-growing applications thanks to differentiating solutions, such as underwater mapping by drone or space navigation.

Advanced Technologies segment: strong demand translates into record deliveries

This segment consists of developing and selling the highest-performance photonic and quantum components (specialty optical fibers, optical modulators, quantum measurement instruments) and products using the most advanced technologies (on-board communication equipment, simulators, autonomous decision-making). These components and products are sold directly to third parties or integrated into the systems of the Navigation & Maritime Robotics segment.

The ramp-up in production rates for this segment continues and enabled to meet the numerous orders to be delivered in the quarter, both for internal needs and for third-party customers. The revenue in this segment thus rose by 28%. The highly diversified customer base includes many leading players in the laser, telecoms, aeronautics, space, defense and quantum industries, who rely on EXAIL as a strategic and recurring supplier.

A current EBITDA margin of 21%

EXAIL TECHNOLOGIES generated €32 million in current EBITDA in the first half of 2023, in line with the expectations for this first year of integration of the new EXAIL group. The current EBITDA margin was down compared to last year on a like-for-like basis and close to that of the second half. It was at a good level and may vary from one half-year to another depending on the mix of margins on the business delivered during the year.

The Navigation & Maritime Robotics segment, which concentrates most of the group's activities, generated a current EBITDA margin of 21% in the first half-year thanks to the progress of major defense programs and deliveries of inertial navigation systems.

The Advanced Technologies segment generated a current EBITDA margin of 18%. It includes high-margin activities, such as optical fibers for laser applications, but also development activities (such as ground drones and certain quantum instruments), which still contributed little to the Group's profitability this year. The profitability of this division was also impacted by the decline in sales of on-board equipment for the aeronautics sector, where customers are waiting for the new version of the ELITE SC distress beacon.

Operating income of €8 million

Depreciation, amortization and provisions amounted to €14 million in the first half of 2023, stable compared to last year. The income from ordinary activities thus stood at €17.4 million.

The other items of operating income represented €9 million, half of which came from the decrease in the value of the PRODWAYS GROUP's shares and had no impact on cash⁵. These PRODWAYS GROUP shares were distributed to the shareholders in June 2023. The balance includes costs related to the employee incentive and retention plan set up by IXBLUE (renamed EXAIL) for several years and the last costs related to the acquisition of IXBLUE. As a result, the Company's operating income amounted to €8 million.

Cost of financial debt up, with a partial effect on cash

The acquisition of IXBLUE was carried out without a capital increase of EXAIL TECHNOLOGIES thanks to a leverage effect created at the level of the subsidiary EXAIL HOLDING, to which GROUPE ECA was contributed. This financial structure offers significant value creation potential, due to the amplification of the effects of the Group's growth through financial leverage. However, it led to an increase in the cost of financial debt, to €12 million in the first half of 2023.

A significant portion of the interest recorded – interest on bonds issued to ICG – is capitalized and therefore has no impact on cash. The disbursements related to interest on the debt represent a little more than half of the expense recorded in the income statement. These costs are expected to decrease in the coming years as the Company gradually deleverages.

Financial structure at the end of June 2023

The cash flow from operating activities⁶ amounted to +€28 million in the first half of 2023. This performance was offset by the strong increase in the WCR (+€31 million), penalized by traditionally unfavorable seasonality between the two half-years, particularly this year for the payment milestones of the BENL program. The WCR was also impacted by a payment delay of one business day (from 30 June to 4 July), for €7 million.

Capex represented €14 million, mainly including investments in R&D, as well as investments in certain production tools.

EXAIL TECHNOLOGIES also received €30 million⁷ thanks to the disposal of the ISP division in the first half of 2023. This sale proceeds was used in July 2023 to acquire 5% of the subsidiary EXAIL HOLDING for €24.5 million (more details on this transaction are available in the press release of 26 July 2023).

At the end of June 2023, the Group's cash position therefore amounted to €70 million (compared to €59 million at the end of 2022). The Group's adjusted net debt³ was relatively stable, at €269 million, including the *in fine* bonds (2030) subscribed by the financial partner ICG. It amounted to €183 million excluding these bonds, which have no cash impact before their maturity.

Perspectives

€139 million in order intake in the first half of 2023, up by 6% vs. H1 2022

The order intake for the half-year was driven by the Navigation & Maritime Robotics segment, with €110 million in new orders, up by €14 million compared to last year on a like-for-like basis. This performance, although relatively disappointing, remains solid given the postponement of certain ongoing calls for tenders in the field of underwater mine counter measures, particularly in the Middle East. Several processes are still underway and EXAIL TECHNOLOGIES will continue to communicate on the progress of these projects while respecting the confidentiality constraints of these processes.

The Advanced Technologies segment recorded orders of €31 million in the first half of 2023, down by €6 million compared to last year. In a context of strong commercial momentum in the optical components activities, the Group has chosen to prioritize the internal needs of the Navigation & Maritime Robotics segment to the detriment of external order intake, in order to be able to meet the significant demand for inertial navigation systems. Orders were also penalized by the decline in sales of onboard equipment for the aeronautics sector, as mentioned earlier in this press release.

Promising and well-oriented markets

The Group's markets remain promising due to the sustained trends in the Group's main applications. In the civilian field, the need for state-of-the-art equipment to carry out hydrography missions remains significant. They are driven by sovereign issues, such as the construction of offshore wind farms, the protection of the oceans or the exploration of the deep seabed. These trends are reflected in the Group's recent order intake; in September it announced a record order in the civil maritime sector for navigation equipment and a new order for the DriX drone.

In the field of Defense, the overall increase in defense budgets worldwide (+\$130 billion in 2022) is supporting the Group's activities. The modernization and dronization of naval forces have begun, enabling navies to carry out protection and surveillance missions more effectively and at lower cost. The French Navy's Center for Strategic Studies thus expects "a proliferation of drones", which should benefit the Group's activities.

EXAIL TECHNOLOGIES achieved a good level of revenue and profitability at the start of 2023. The Group confirms its revenue growth target for 2023 of more than 15% compared with 2022 on a like-for-like basis. The Group's executive management therefore expects significantly higher revenue in the second half of the year.

Definition of alternative performance indicators

- **Current EBITDA:** Operating income before "depreciation, amortization and provisions", "other items of operating income" and "Group share of the earnings of affiliated companies".
- Income from ordinary activities: Operating income before "other items of operating income" and "Group share of the earnings of affiliated companies".
- Cash-flow from operations: Cash-flow from operating activities before change in working capital requirements and after neutralization of the net borrowing cost and taxes.
- Adjusted net debt: Net debt excluding lease liabilities resulting from the application of IFRS 16 and including the value of treasury stock.

Comparative financial information

The Group carried out several disposals in December 2022 and in the first half of 2023. A major acquisition (that of IXBLUE, now EXAIL SAS) was completed in September 2022.

The disposals that have been carried out are in the IFRS financial statements treated in accordance with IFRS 5, the standard relating to discontinued operations which involves the classification of the contribution of discontinued operations on a single line of the income statement for the period but also that given for comparison. The Group's income statement, for the first half of 2023 as for the first half of 2022, therefore does not include the contribution of the operations sold in 2022 and 2023 before the line entitled "Net income from discontinued operations". Note 1.3 to the consolidated financial statements explains the consequences of the application of IFRS 5, in particular on the 2022 income statement.

The Group completed the major acquisition of the IXBLUE group in the second half of 2022 (see Note 2 to the consolidated financial statements). As a result of this acquisition, the financial statements for the first half of 2023 are not comparable to those of the first half of 2022, the scopes being significantly different: the income statement for the first half of 2022 only includes GROUPE ECA and its subsidiaries. As the acquisition of IXBLUE is very significant, the Group has decided to provide comparable 2022 financial information in its half-year activity report.

Historical financial information

The IXBLUE group contributed to the 2023 half-year financial statements but did not contribute to those of 2022 (acquisition in September 2022). A like-for-like income statement as at 30 June 2022 has been drawn up. This comparable income statement includes the contribution that would have been that of IXBLUE if the acquisition had been completed on 1 January 2022, by neutralizing reciprocal transactions with companies in the scope. Restatements for comparability were added concerning the structuring of the acquisition.

The tables below have been prepared on the basis of the income statement for the first half of 2022 as published in the 2023 half-year financial statements. To obtain comparable information, the following restatements for comparability have been made:

- addition of the contribution of the IXBLUE group that would have been its own if the acquisition had been completed on 1 January 2022 rather than on 29 September 2022; this contribution is net of reciprocal transactions between the former scope and IXBLUE as well as internal margins;
- restatements for comparability have been applied, not relating to the transactions but only to items related to the acquisition itself:
 - o cancellation of the acquisition costs,
 - o cancellation of the fees related to debts that have been repaid on the acquisition date,
 - o addition of the expenses representing the theoretical cost of acquisition liabilities for the amount raised on acquisition,
 - o cancellation of the negative impact of the end of the tax consolidation of GROUPE ECA by EXAIL TECHNOLOGIES,
 - o taking into account of the theoretical tax impacts of the previous restatements.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

The condensed half-year consolidated financial statements of EXAIL TECHNOLOGIES cover a period of six months, from 1 January to 30 June 2023. They were approved by the Board of Directors on 27 September 2023.

The Group notes seasonal variations in its activities that may affect the level of revenue from one half-year to another. Thus, the interim results are not necessarily indicative of those that can be expected for the full year.

The highlights of the first half of the year are described in the activity report.

Note 1 Accounting principles

Note 1.1 Standards applied

The Group prepares half-year consolidated financial statements in accordance with IAS 34 "Interim financial information". They do not include all the information required for the preparation of the annual financial statements and should be read in conjunction with the consolidated financial statements for the financial year ended on 31 December 2022, as they appear in the Universal Registration Document filed with the French Financial Markets Authority (Autorité des Marchés Financiers – AMF) on 28 April 2023 under number D.23-0384.

The accounting principles used for the preparation of the half-year consolidated financial statements comply with the regulations and interpretations of the International Financial Reporting Standards (IFRS) as adopted by the European Union as of 30 June 2023. These accounting principles are consistent with those used in the preparation of the annual consolidated financial statements for the financial year ended on 31 December 2022.

The Group has applied all standards, amendments and interpretations that are mandatory for financial years beginning after 1 January 2023:

Standards, interpretations and amendments adopted by the European Union and whose application is mandatory as of 1 January 2023

The application over the period of the following new standards and interpretations did not have a significant impact on the consolidated financial statements at 30 June 2023:

- amendments to IAS 12 Income taxes: deferred tax related to assets and liabilities arising from a single transaction;
- amendments to IAS 1 Presentation of the financial statements and Practical application guide 2: disclosures on accounting policies;
- amendments to IAS 8 Accounting policies, changes in estimates and errors;
- IFRS 17 and amendments Insurance contracts.

Standards, interpretations and amendments not adopted by the European Union as of 30 June 2023 or whose application is not mandatory as of 1 January 2023:

- amendments to IAS 7 Statement of cash flows and IFRS 7 Financial instruments: Disclosures on supplier financing arrangements;
- amendments to IAS 12 Income taxes: International tax reform Rules of the second pillar of the model;
- amendments to IAS 1 Presentation of the financial statements: classification of current and non-current liabilities Deferral of the effective date; non-current liabilities with covenants;

amendments to IFRS 16 - Leases: lease liability in a sale and sale-leaseback.

The process carried out by the Group to determine the potential impacts of standards not applicable as of 30 June 2023 on the Group's consolidated financial statements is ongoing. At this stage of the analysis, the Group does not expect any material impact on its consolidated financial statements.

Note 1.2 Basis of preparation

The financial statements are presented in euros and are rounded to the nearest thousand.

The financial statements are prepared on a historical cost basis, with the exception of derivative instruments and non-consolidated securities, which have been measured at their fair value. Financial liabilities are measured at amortized cost. The carrying amount of hedged assets and liabilities and the related hedging instruments corresponds to their fair value.

The preparation of the financial statements requires that the Executive Management of the Group or the subsidiaries make estimates and assumptions that affect the reported amounts of assets and liabilities on the consolidated statement of financial position, the reported amounts of income and expense items on the income statement and the commitments relating to the period under review. The actual results could be different if the reality differs from the assumptions and estimates used.

The above-mentioned assumptions mainly concern:

- the valuation of the recoverable amounts of assets;
- the calculation of research and development expense (see Note 6.2);
- the calculation of provisions for risks and charges (see Note 11);
- the calculation of income upon completion of work in progress;
- the calculation of pension and other post-employment benefit obligations (assumptions set out in Note 5.2);
- the valuation of deferred taxes (see Note 9.2).

As the Group's consolidated companies operate in different sectors, the valuation and impairment methods used for certain items may vary according to the sector.

The valuation methods and rules applied to the half-year consolidated financial statements are similar to those described in the notes to the consolidated financial statements for 2022 (Universal Registration Document filed with the AMF on 28 April 2023).

Note 1.3 Restatement of financial information for prior years

In 2023, the consolidated financial statements of EXAIL TECHNOLOGIES underwent significant changes in presentation compared to the first half of 2022, related to changes in the scope of consolidation and discontinued operations (IFRS 5).

Activities classified as discontinued operations in 2021 were sold in 2022. As part of its refocusing on the activities of its subsidiary EXAIL HOLDING, in the second half of 2022 the Group launched the project to sell the activities of the Engineering & Protection Systems division. In accordance with IFRS 5, the financial statements at 30 June 2022 have been restated. The Group applies IFRS 5 – *Non-current assets held for sale and discontinued operations*, which requires a specific recognition and presentation of assets (or groups of assets) held for sale, along with discontinued operations and operations sold or being sold (see Note 12). Throughout the notes, the information relating to 30 June 2023 is compared with the restated information for 30 June 2022 as explained below:

- in the first half of 2022, the NUCLÉACTION group was treated in accordance with IFRS 5; this group was sold in December 2022 and therefore no longer contributes to the 2023 financial statements;
- in October 2022, a disposal process was announced that included other subsidiaries (VIGIANS PROTECTION INCENDIE and its subsidiaries, as well as SERES INGÉNIERIE and STEDY). This project, which ended the existence of the Engineering & Protection Systems division, was completed in March 2023. The contribution of VIGIANS PROTECTION INCENDIE, and its subsidiaries, SERES INGÉNIERIE and STEDY to the income statement and the statement of cash flows at 30 June 2022 has therefore been reclassified on a separate line, in accordance with IFRS 5, as in the 2022 annual financial statements. Note 12 details all impacts of discontinued operations on the statement of financial position and income statement.

Impact of restatements on the financial statements

The impacts of the changes made to the income statement for the first half of 2022 are described in the following table:

The entire contribution of SERES, STEDY and VIGIANS PROTECTION INCENDIE is reclassified on a single line of the income statement. More information on the result of discontinued operations is given in Note 12.

Note 2 Scope of consolidation

The full list of consolidated companies is included in Note 14.

Several activities were sold in the first half of 2023, as explained in Note 1.3. There was no acquisition in the first half of 2023.

On 29 September 2022, the Group completed the major acquisition of the IXBLUE group (now EXAIL). The fair value measurements of the assets, liabilities and contingent liabilities of EXAIL SAS (former IXBLUE SAS) and its subsidiaries have not been finalized; they may be subject to adjustments during the 12 months following the acquisition date, *i.e.* until October 2023. The acquisition cost included in 2022 an estimate of a price adjustment related to the circumstances existing at the acquisition date, the amount of this adjustment became final in the first half of 2023.

As a result of this acquisition, the financial statements for the first half of 2023 are not comparable to those of 2022, the scopes being significantly different. The Group has decided to disclose comparable 2022 financial information in its half-year activity report. In the notes to the consolidated financial statements as a whole, the data at 30 June 2022 never include the contribution of IXBLUE.

Note 3 Segment information

In accordance with IFRS 8 – *Operating segments*, the segment information presented below is based on the internal reporting used by Executive Management to assess the performance of and allocate resources to the various segments. Executive Management is the principal operational decision maker within the meaning of IFRS 8.

The two segments defined as operating segments from 2023 are as follows:

- the Navigation & Maritime Robotics segment includes the Group's two main activities, vertically integrated: the sale of navigation systems, positioning systems, and sonars; and the commercialization of drones and autonomous drone systems for maritime applications, integrating the Group's navigation systems and other equipment in order to offer the most effective robotic solutions:
- the Advanced Technologies segment consists of developing and selling the highest-performance photonic and quantum components (specialty optical fibers, optical modulators, quantum measurement instruments) and products using the most advanced technologies (on-board communication equipment, simulators, autonomous decision-making). These components and products are sold directly to third parties or integrated into the systems of the Navigation & Maritime Robotics segment.

The segment information for 2022 cannot be prepared in a comparable manner with the new segments. It is presented according to the Group's previous organization.

The key indicators by division presented in the tables below are the following:

- the backlog, which corresponds to revenue yet to be recognized in respect of orders recorded;
- · revenue includes revenue made with other divisions;
- current EBITDA;
- operating result;
- · operating income;
- the Research and Development expenses recognized in the assets during the financial year;
- other tangible and intangible investments.

Note 3.1 Reconciliation of the non-IFRS indicators and segment indicators with the consolidated operating income

The Group uses non-IFRS financial information for the purposes of information, management, and planning because they offer a better assessment of its long-term performance. This additional information is not a substitute for any IFRS measures of operating and financial performance. The data presented by the Group are always non-adjusted consolidated data, like the segment data, unless expressly stated otherwise.

Operating income includes all income and expenses other than:

- interest income and expenses;
- other financial income and expenses;
- · corporate income tax.

To make it easier to compare financial years and monitor its operating performance, the Group has decided to isolate certain non-recurring items of operating income and present "Profit (loss) from continuing operations". It also uses a current EBITDA indicator. These non-accounting indicators do not constitute financial aggregates defined by IFRS; they are alternative performance indicators. They may not be comparable to similarly named indicators by other companies, depending on the definitions used by them.

- The operating result is the operating income before "Other items of operating income", which include the restructuring costs, recognized or fully provisioned if they are liabilities arising from a Group obligation to third parties, which stem from a decision taken by a competent body, and which materialize before the reporting date through the announcement of said decision to third parties and provided the Group no longer expects consideration for these costs. These costs consist primarily of compensation for termination of employment contracts, severance pay, as well as miscellaneous expenses. The other items included on this line of the income statement concern the costs of free share allocations, the costs of acquisition and disposals of activities, amortization of acquired intangible assets recorded under business combinations, impairment of goodwill, and all unusual items by their occurrence or amount.
- Current Earnings Before Interest, Taxes, Depreciation and Amortization (EBITDA) are defined by the Group as operating income before
 "Net depreciation, amortization and provisions", "Group share of the earnings of affiliated companies" and "Other items of operating
 income"

The 30 June 2023 and 2022 segment income statements are reconciled below with the Group's consolidated financial statements. They are prepared in accordance with the Group's operational reporting. The differences between the segment information (internal reporting) and the consolidated financial statements concern in particular the scope of continuing operations. Throughout 2022 the Group included in its reporting NUCLÉACTION and its subsidiaries (sold in December 2022), VIGIANS PROTECTION INCENDIE and its subsidiaries, SERES INGÉNIERIE and STEDY (sold in February-March 2023), despite the existence of disposal projects. These companies met the conditions justifying the application of IFRS 5 – Non-current assets held for sale and discontinued operations. The reclassification of their contribution on a specific line of the income statement thus creates a discrepancy between the operating reporting and the 2022 consolidated financial statements.

Note 13.2 Exceptional events and litigation

The Group is involved in various legal proceedings. After reviewing each case and seeking counsel, the provisions considered necessary have, as applicable, been recorded in the financial statements.

At the end of June, EXAIL ROBOTICS received a proposal for an adjustment following a tax audit conducted in the second quarter and covering the 2019 to 2021 financial years. The proposed correction represents €0.7 million in tax. The company considers, after in-depth analysis of the grounds for rectification with its advisors, that it has serious arguments to contest almost all of the claims in the adversarial proceeding.

The procedures mentioned in the notes to the 2022 financial statements did not change significantly during the half-year.

Note 13.3 Subsequent events

In accordance with existing commitments, EXAIL TECHNOLOGIES acquired 5% of the share capital of EXAIL HOLDING on 25 July 2023, thus strengthening its stake in its subsidiary.

No other significant events took place between 30 June 2023 and the date of the Board of Directors meeting that approved the consolidated financial statements.
